In case of Private Practice, self – declaration of experience in relevant field on letterhead should be enclosed in attached format (ANNEXURE – C). e. Registration Certificate issued by State / Central statutory body/ Council of respective medical discipline/branch for which consultant is applying for, (certificate should be valid on the last date of submission of application) In case of validity of Registration Certificate is expired and renewal of registration is pending, the selected candidate should provide the proof of applying renewal of registration before executing the agreement.
