This has reference to the subject Request for Proposal. Request for proposal was floated by NPCIL on 31.12.2024 inviting proposals from private / public industries for setting up 220 MWe Bharat Small Reactor (BSR). In this regard, the following may please be noted:

#### **NPCIL Invites Industry Consultation on Revised Nuclear Power Business Model under SHANTI Bill with reference to RFP No. NPCIL/BSR-220MWe/2024/01**

In furtherance of the Government of India's policy to enable private industry access to reliable and carbon-free nuclear power, as articulated by the Hon'ble Finance Minister in her Budget Speech, Nuclear Power Corporation of India Limited (NPCIL) had earlier issued a Request for Proposal (RFP), outlining the Business Model for industry participation. Considering the strong interest received from industrial stakeholders, the timeline for submission of proposals has been extended up to 31 March 2026.

The RFP was originally structured in accordance with the provisions of the Atomic Energy Act, 1962 and the Civil Liability for Nuclear Damage Act, 2010, which were applicable at that time. Subsequently, the Sustainable Harnessing and Advancement of Nuclear Energy for Transforming India Bill, 2025 (SHANTI Bill), having been passed by both Houses of Parliament and assented to by the Hon'ble President of India. This landmark legislation provides an enabling and liberalised framework for enhanced industry participation in the nuclear energy sector.

In light of the revised statutory regime, NPCIL proposes to rework the underlying business model to ensure full alignment with the provisions and intent of the SHANTI Bill. To this end, NPCIL seeks structured inputs from industry stakeholders to ensure that the revised model adequately addresses implementation requirements while safeguarding national policy objectives.

Accordingly, NPCIL is convening a consultative workshop, as per the schedule indicated below, to deliberate upon and evolve an appropriate approach for implementation of the Bharat Small Reactor (BSR) programme in the post-SHANTI Bill context.

All interested industrial entities are cordially invited to participate in the meeting.
